TAX LEVY ORDINANCE

ORDINANCE NO. 2022 - 01

AN ORDINANCE OF THE BOROUGH OF FREEBURG, COUNTY OF SNYDER, COMMONWEALTH OF PENNSYLVANIA, FIXING THE TAX RATE YEAR 2022.

The proposed Ordinance shall fix the tax rate on all real estate within the Borough of Freeburg for the year 2022 at Ten (10.0) mills. TAX LEVY ORDINANCE

ORDINANCE NO. 2022 - 01

**AN ORDINANCE OF THE BOROUGH OF FREEBURG, COUNTY OF SNYDER,
COMMONWEALTH OF PENNSYLVANIA, FIXING THE TAX RATE
FOR THE YEAR 2022.**

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Borough Council of the Borough of Freeburg, County of Snyder, and Commonwealth of Pennsylvania,;

That a tax be and the same is hereby levied on all real property within the Borough of Freeburg subject to taxation for the fiscal year 2022 as follows:

Tax rate for general purposes, the sum ofTen (10.0) mills on each dollar of assessed valuation,
or the sum ofOne Hundred (100) cents on each one hundred dollars of assessed valuation.

The same being summarized in tabular form as follows:

	Mills on Each Dollar of Assessed Valuation	Cents on One Hundred Dollars of Assessed Valuation
Tax Rate for General Purposes	Ten (10.0) Mills	One Hundred (100) Cents


That any ordinance, or part of ordinance, conflicting with this Ordinance be and the same is hereby repealed insofar as the same affects this Ordinance.


