

**BOROUGH OF FREEBURG, SNYDER COUNTY, PENNSYLVANIA,**

**REAL ESTATE TAX RESOLUTION FOR TAX YEAR 2023 2023-1**

WHEREAS, the Pennsylvania Legislature by 8 Pa.C.S. §1301 et seq., authorized boroughs to impose real estate taxes on land and improvements thereon by the adoption of a resolution rather than enacting an ordinance provided that there is no increase in such taxes from the previous year; and

WHEREAS, the Borough of Freeburg, Snyder County, Pennsylvania, desires to adopt a real estate tax resolution for the year 2023 at the same tax rate as was imposed for the tax year 2022; and

NOW, THEREFORE, BE IT RESOLVED AND IT IS HEREBY RESOLVED BY THE Council of the Borough of Freeburg that the Borough of Freeburg is hereby authorized to impose a tax upon the real estate situated within the Borough as follows:

That a tax be and the same is hereby levied on all real property within the Borough of Freeburg subject to taxation for the fiscal year 2023 as follows:

Tax rate for general purposes, the sum of .....Ten (10.0) mills on each dollar of assessed valuation,  
or the sum of .....One Hundred (100) cents on each one hundred dollars of assessed valuation.

The same being summarized in tabular form as follows:

	Mills on Each Dollar of Assessed Valuation	Cents on One Hundred Dollars of Assessed Valuation
Tax Rate for General Purposes and	Ten (10.0) Mills	One Hundred (100) Cents;

RESOLVED, FURTHER, that any ordinance or resolution, or part of ordinance or resolution, conflicting with this Resolution be and the same is hereby repealed insofar as the same is in conflict with the terms hereof.

Adopted this 20th day of December, 2022, with an effective date of January 1, 2023.




