RESOLUTION of the Freeburg Municipal Authority of Freeburg, Snyder County, Pennsylvania duly made by motion, seconded, and carried at its regular meeting May 14, 2026.

RESOLVED, that the rates for water service repairs and improvement to the improved parcels of real estate within the Borough of Freeburg, need to be increases in order to meet the ongoing operating expenses and debt services obligation of the Authority, and

RESOLVED, that on motion duly made, seconded, and carried, the water service repair and improvement rates to be charged to the owner of record of the improved real estate parcels connected to the public water system of the Authority shall be as follows:

Daily Water Rate	\$1.78/day
Sewer Hook-up, connection only	\$500.00/each
Water Hook-up, connection only	\$500.00/each
Horn & Installation	\$600.00
Horn Only	\$500.00
Meter Eye Relocation	\$100.00
Posting Shut Off Notices	\$ 50.00
Sewer Service, quarterly fee	\$150.00
Sewer Line Inspection fee	\$100.00
Turn Off/On Water, for repairs	\$ 50.00
Turn Off Water – Cancel Service	\$150.00
Turn Off Water – Non-Payment	\$150.00
Turn On Water	\$150.00

Water Meter & Installation	\$600.00
Water Meter Only	\$400.00
Water Usage – Quarterly fee, 7,000 gallons	\$160.00
Water Usage – Overage 1, 8,000 to 13,000 gallons	\$15.00/1,000 gallons
Water Usage – Overage 2, 14, 000 and over	\$18.00/1,000 gallons
ISF Check Collection Fee	\$50.00
Finance Charge	25%
